An Act relating to education; repealing 70 O.S. 2011, Sections 3-163, 3-164, 3-165 and 3-166, as amended by Sections 592, 593, 594 and 595, Chapter 304, O.S.L. 2012 (70 O.S. Supp. 2016, Sections 3-163, 3-164, 3-165 and 3-166), which relate to the P-20 Data Coordinating Council, the P-20 Data Coordinating Council Revolving Fund, the Educational Quality and Accountability Board and the Educational Quality and Accountability Board Revolving Fund; repealing 70 O.S. 2011, Section 6-101.17, which relates to the Teacher and Leader Effectiveness Commission; and providing an effective date.

SUBJECT: Education

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. REPEALER 70 O.S. 2011, Section 3-163, as amended by Section 592, Chapter 304, O.S.L. 2012 (70 O.S. Supp. 2016, Section 3-163), is hereby repealed.

SECTION 3. REPEALER 70 O.S. 2011, Section 3-165, as amended by Section 594, Chapter 304, O.S.L. 2012 (70 O.S. Supp. 2016, Section 3-165), is hereby repealed.

SECTION 4. REPEALER 70 O.S. 2011, Section 3-166, as amended by Section 595, Chapter 304, O.S.L. 2012 (70 O.S. Supp. 2016, Section 3-166), is hereby repealed.

SECTION 5. REPEALER 70 O.S. 2011, Section 6-101.17, is hereby repealed.

SECTION 6. This act shall become effective November 1, 2017.
