- Effective November 1st
- DHS call tracking
  - Number of anonymous calls
  - Recordings for 12 months

# Other Abuse Bills

- HB 1273
  - Effective November 1st
  - Sex exploitation includes forcing prostitution
- HB 1066
- Effective November 1st
- Reports must include sex exploitation

# HB 2069

- Effective immediately
- Residency for foster children
  - Local school before foster care
  - Current foster parent's local school
  - Prior foster parent's local school
  - Transfer school for another student in the foster home

### HB 1460 and 1911

- Effective November 1st
- State authority over carrying knives
  - Switchblades and auto open knives
- · Examine district policies on weapons

# SB 0234

- Effective November 1st
- · Peace officers can carry at school
  - Authorized carry
  - OK Self Defense Act

# Other Law Enforcement Bills

- SB 0055
  - · Attempted control of weapon is A&B
- HB 1318
  - · Off duty attacks are in line of duty if related
- SB 0219
  - · Concealed carry options
- SB 0362
  - Recording law enforcement actions

#### **HB 2014**

- Effective immediately
- Board may designate gun carry at school
  - Valid armed security guard license
  - · Reserve peace officer certificate
- Considerations
  - Training expenses
  - Need a policy
  - Consult insurer

#### HB 1423

- Effective immediately
- · Transportation for AG ed and FFA
- Not required for all related activities
- · Consider SB 50
  - Younger student eligibility

# SB 0262

- Effective August 20th
- · OSDE must develop workplace safety training
  - Must also develop rules
  - District not required to offer training at this time

# HB 1150

- Effective immediately
- Private treatment facilities can now be located within 1,000 feet of the school

- · Open Meeting Act Executive Session
- Individuals in a real estate transaction may participate in executive session if representation agreement in place
